



Dear Westglen Village and South Residents,

We hope that you and your family are healthy during these unprecedented times. It is with great pleasure that we announce... **YES! THE POOL IS GOING TO OPEN ON MONDAY JUNE 15, 2020... WITH NEW GUIDELINES - SEE BELOW.**

The opening of the pool is not determined by Westglen Trustees, but rather by Unique Pools and the St. Louis County Department of Health. Unique Pool Management is implementing changes to comply with the new safety standards required by St. Louis County Dept. of Health. **Changes to the operation of our pool include:**

- 1. A signed waiver (enclosed) is required before you can receive your pool passes/key fobs, along with being current on your HOA dues.** You may pay your dues thru the community portal at <https://portal.cpmgateway.com>. This goes directly to our community property management company. Payment on dues is never received by Unique employees at the pool.
- 2. We are implementing a NEW KEY FOB PASS SYSTEM.** Much like a hotel pool, the new wireless device will allow entry into our main gate, which will now be locked at all times. We are required to have a log of everyone who enters the pool. It will be required for each family to enter separately using their own keyfob. **If you don't have your keyfob, you won't be allowed to enter the pool.**
- 3. PLEASE SEE KEYFOB PICKUP DAY AND TIMES AT THE BOTTOM OF YOUR WAIVER** for when you can submit your signed waiver and receive your key fobs at the pool. Key fobs will NOT be held or distributed by Unique employees at the pool. If you cannot make one of the designated distribution times please email the waiver to westglenpool@gmail.com for future distribution dates.
- 4. No private parties during or after regularly scheduled hours.**
- 5. No admittance to non member guests.**
- 6. Pool capacity restricted to a maximum of 75 guests.** We are looking into the possibility of implementing an online reservation system.
- 7. Limited furniture will be spaced in groups 6 ft apart.** You may also bring your own chairs. Use of towels on furniture will be required to limit contact. Members are also encouraged to bring disinfectant wipes to wipe down any furniture prior to use.
- 8. Patrons and attendants shall wear fabric or disposable face coverings when not in the pool or eating. Wearing a mask while in the pool is prohibited for safety. Eating and drinking while in the pool is not allowed.**
- 9. No pool toys or floatation devices will be allowed**
- 10. Lane lines will not be used this year.** Lap swimming will only be available when the pool capacity will allow it.
- 11. Unique Pool Management will disinfect frequently touched surfaces**

Enclosed is the waiver that we need signed along with key fob pickup days and times at the pool. We are also gathering email addresses to better communicate to our community in the future. A list of complete changes and pool rules will be distributed with your new key fob.
